## Trustee's report and audited financial statements of the HKBU 1998 Superannuation Fund for the 2015-16 financial year

1. The Council resolved to receive the audited financial statements of the HKBU 1998 Superannuation Fund and the Trustee's report on the operations of the Fund for the 2015-16 financial year.

## **Funding support for Incentive Award Scheme 2016-17**
