# Affixing of the University's common seal to two consultancy agreements and other documents pertaining to the Lui Seng Chun project

4. The University was selected by the Government in 2009 to revitalize the historic Lui Seng Chun under the Government Revitalising Historic Buildings Through Partnership Scheme. The Council resolved to approve the affixing of the University's common seal to the consultancy agreements and other documents pertaining to/arising from the "Conversion of Lui Seng Chun into HKBU Chinese Medicine and Healthcare Centre" project as well as the arrangement for the authentication of the affixing of the common seal.

# Measure to cope with reduction in government funding resulting from civil service pay adjustment

5. As a result of the Government's implementation on 1 January 2010 of a downward pay adjustment of 5.38% for civil servants in the Upper Salary Band, i.e. civil servants remunerated at Point 34 & above on the Master Pay Scale, the government funding to the University will correspondingly be reduced. In order to cope with the funding reduction, the Council resolved to implement on 1 March 2010 a downward pay adjustment of 5.38% for staff in the Upper Salary Bands in accordance with a set of implementation guidelines.
