Hong Kong Baptist University Foundation Start-up Fund

10. The Council approved the transfer of (a) the balance of funds under the University Foundation Fund (which has been replaced by the HKBU Foundation), endowment funds on scholarships and bursaries, and three other designated endowment funds, and (b) the balance of the donations received under the four rounds of UGC Matching Grant Schemes after approved allocation for various designated University activities, totalling HK\$440.3 million as at 31 January 2009, to the HKBU Foundation as its start-up fund.
