#### **Acceptance of donations**

- 1. The Council confirmed the decision made through the circulation of paper:
  - (a) to accept the donation of HK\$30 million by the estate of the late Madam Kwok Chung Bo Fun, with \$26.5 million designated for the Graduate School Development Fund and \$3.5 million for the establishment of "The Faith Hope Love Endowment Fund" in support of character development programmes; and
  - (b) to accept from Mr. and Mrs. Lau Chor Tak the donation of a residential unit situated at Cité 33 on Lai Chi Kok Road in Kowloon.

#### **Appointment to the Council**
